### **Conclusion based on the results of the assessment of educational programme 7M01612 – History**

Educational programme 7M01612 – History meets the requirements of the State Educational Standards of Higher Education and Postgraduate Education of the Republic of Kazakhstan, the professional standard for teachers, and the modern demands of the education system and labour market. The programme received high scores in all five assessment blocks.

- Key findings of the review:
- The content of the educational programme is relevant, scientifically sound and focused on current trends in historical science and teacher training.
- The programme is based on a competency-based approach, has a modular structure and is clearly focused on learning outcomes and the practical activities of future teachers.
- The educational programme is highly technological and manageable, with logical consistency between objectives, learning outcomes, subject content and assessment methods.
- The educational programme is realistic and feasible, supported by qualified staff, material and technical resources, information and methodological resources.
- Mechanisms for monitoring and evaluating learning outcomes are clearly defined, and various forms of learning and final assessment are provided to ensure the verifiability and manageability of the educational programme.
- The existence of a detailed development plan for the educational programme for 2024–2029 increases its sustainability, competitiveness and prospects.

The total score is 116 out of a possible 120, which indicates the high quality of the educational programme and the feasibility of its implementation in the higher education system.

**Conclusion:** Educational programme 7M01612 – History is recommended for implementation and can be used as a model for high-quality training of teaching staff in the field of history. During implementation, it is recommended to continuously improve methods of using modern technologies, strategies, teaching methods and techniques that contribute to the achievement of learning outcomes.
