

PUBLICATION ETHICS

The editorial policy of the journal "Biological Sciences of Kazakhstan" is guided by the traditional ethical principles of scientific periodicals set out in the Committee on Publication Ethics: COPE: <https://publicationethics.org/> Guide on the Principles of Scientific Publishing Ethics for Journal Editors.

Duties and rights of the editor:

- defines reviewers for each submitted article that has passed the primary selection for compliance with technical requirements,
- based on the reviews of the reviewers at the meeting of the editorial board, makes the final decision on the publication / rejection of the submitted material.

In his decision, the editor-in-chief is guided solely by scientific considerations and compliance with publishing standards. The decision of the editor-in-chief and the editorial board should not depend on gender, nationality, religion and other personal qualities of the author / group of authors.

Responsibilities and rights of reviewers:

Each manuscript submitted for review is considered a confidential document. The reviewer cannot use in his publications the materials contained in the submitted manuscript for review. The reviewer can send the material to third parties only with the permission of the editor-in-chief,

According to the policy of peer review of the publication, the journal uses the procedure of one-sided "blind" peer review. The object of peer review should be the results of the research obtained, and not the author / group of authors. An expert opinion should not depend on gender, nationality, religion and other personal qualities of the author / group of authors,

The reviewer must submit to the editorial office an objective assessment of the work, if necessary, suggest options for improving the submitted material.

The reviewer must refuse to review the material by notifying the editorial board about this, if he is not experts on the topic of the material, if he has identified a conflict of interest.

For authors:

Sending articles to the editorial office and signing a public offer means that the publication of the submitted article in the journal "Biological Sciences of Kazakhstan" does not violate anyone's copyright. The author (authors) transfers to the founder of the journal non-exclusive rights to use the scientific article for an unlimited period by posting full-text network versions of issues on the journal's website.

The author (authors) is responsible for the illegal use of intellectual property objects, copyrighted objects in a scientific article in full in accordance with the current legislation of the Republic of Kazakhstan.

The author (s) confirms that the submitted article has not been previously published anywhere, has not been sent, and will not be sent for publication to other scientific publications.

The author (s) agree that in the event of violations of the ethics of scientific publications after the publication of an article, a retraction procedure can be applied to it.

The author (authors) agree to processing in accordance with the law of the Republic of Kazakhstan "On

personal data and their protection "dated June 25, 2020 No. 347-VI of their personal data, namely: surname, first name, patronymic, academic degree, academic title, position, place (s) of work and / or training, contact information on place of work and / or training, in order to publish the submitted article in a scientific journal.

The author (authors) guarantees that the materials of the submitted article do not contain information constituting a state, commercial or other secret protected by the legislation of the

Republic of Kazakhstan, and bears independent responsibility for the content of such information in the article.

The author (authors) agree with the rules for preparing the manuscript for publication, approved by the editorial board of the journal "Biological Sciences of Kazakhstan", published and posted on the official website of the journal.
